This clarification is being provided to all known and registered correspondents in response to questions received. The following provisions shall be incorporated into the original Invitation for Bid (IFB) and become a part thereof.

- 1) Any and all references to "Brand Name" as used in item #1 on page 4, are intended to be "Brand Name or Equal", whether or not the words "or Equal" are written out in full. An item shall be considered to be "equal" to the specified brand if in the opinion of the Chief Procurement Officer the County can reasonably anticipate sufficiently similar quality, capacity, durability performance, utility and productivity as provided by the annotated brand.
- 2) Each vendor responding to the IFB must be registered in the System for Award Management (SAM) and eligible to receive federal contracts. The System for Award Management (SAM) is an official website of the U.S. government. SAM consolidated the capabilities of CCR/FedReg, ORCA, and EPLS. There is NO cost to use SAM. Register to do business with the U.S. government for free directly from <https://www.sam.gov/portal/SAM/#1>. Note: "Line 22" as added on the Revised Submittal Form attached.
- 3) A "REVISED" Mandatory Bid Submittal Form is attached to replace the original and should be used in lieu. This clarifies the Add/Alternate item for the cost differential between the 1030 and 1530 gallon tanks.
