Question 1: Do you have a budget for this section?

Answer: There is no individual budget listed for this section, only a collaborative budget amount for all turf management/mowing for all sections has been provided by the department. The collaborative budget amount is \$190,000 for all sections.

Question 2: If we have the type of insurance you require but not a high enough coverage amount are we able to increase this upon award of contract or would we need to increase this before we can even be considered for this bid?

Answer: Please refer to item number 32. Insurance on pages 15-17 of the original bid document for insurance requirements where it states "Proof of coverage as contained herein shall be submitted fifteen (15) days prior to the commencement of work and such coverage shall be maintained by the bidder for the duration of the contract period". Please note any exceptions on the mandatory "Exceptions Page". Also, the following sections are not required for this particular bid and thus will be removed and revised as follows:
