**Question 1:** On Page 21, line #3, should we calculate the shipping cost based on the 17 loads sent out last year or how?

**Answer:** Please calculate the Per Annum, Year One Transportation Costs on page 21, line item #3 using the information provided in the bid document. Yes, this includes the 17 loads as listed on page 3 of the bid document.

**Question 2:** If we are wanting to list a transportation charge per load, will that charge need to be listed on the exceptions page on page 26? If not there, where should it be noted?

**Answer:** All transportation costs should already be included in your costs as listed in the Per Annum, Year One Transportation Costs listed on page 21, line item #3. If you would like to explain how you came up with that number, you may write it on the exceptions page if you'd like, but you would have to make it clear that this is not an additional cost to line item #3 on page 21, but an explanation of the already listed cost. Only page 21, line item #2, #3, and #4 will be read during the bid opening. These costs should be clear and concise to easily identify which bidder is in the best interest of the County.
