Question 1: On page 3, the bid calls for 2 local phone numbers, does this mean an out of state company is excluded from submitting a bid?

Answer: **No, an out of state company is acceptable and encouraged to submit a bid, just as long as two phone numbers are provided. They do not have to be "local" phone numbers.**

Question 2: Our vehicles are not commercial vehicles but have been retrofitted with dump capabilities. Are you only looking for tri-axles "dump trucks" and as a result only commercial drivers?

Answer: **Yes, we need tri-axle dump trucks commercial vehicles.**
