**Tree Removal at Running Water Drive**

**Introduction**

The Georgetown County Public Services Department, Stormwater Division, is seeking sealed bids for Tree Removal at Running Water Drive located along Running Water Dr. in Murrells Inlet, SC 29576. The bid should include any and all charges for the removal of trees, labor, supervision, equipment, services, and expertise necessary to perform the work specified. Work is to be performed by a contractor that derives a majority of its annual income from arboricultural work and whose employees are trained and skilled in all phases of tree service work. See attached Exhibit A for maps identifying the sections for tree removal within the median at Running Water Drive. See below scope of services for further details.

**Scope of Services**

1. All trees to be removed have been pre-marked with an orange spray painted "X". All trees to remain have been pre-marked by pink flagging. The County reserves the right to change, add, or delete areas or quantities to be removed and price may be adjusted accordingly.
2. No trees will be cut except those that are within the designated areas as marked. See Exhibit A attached for maps and photos.
3. Stump grinding should be provided to all stumps. All stump grinding material is to be removed immediately following grinding.
4. Tree removals will include topping and other operations necessary to safely remove the assigned trees.
5. All trees not being removed are to be protected from unnecessary damage. If damage/accidentally removal occurs, the Contractor shall either replace the tree with one of similar size and species as designated by the County and at no additional expense to the County, and/or the dollar value of such damaged/removed trees, shall be deducted from the amount owed to the Contractor. The decision over replacement of trees or monetary reimbursement will be that of the County.
6. As far as practicable all tree removal operations shall be in an orderly and progressive manner, exercise all possible protection to young growth and shall give due consideration to disturbances which will affect soil movement or impair and aggravate water movement.
7. All labor, supervision, equipment, materials, supplies, etc. necessary for the execution of this work must be provided for by the contractor at no additional cost to the County.

8. All bidders must have proper equipment and supplies which are necessary to perform the work as outlined in these specifications. The County may inspect such equipment or supplies prior to the awarding of a contract.
9. The Contractor shall schedule work between the normal business hours of 8:00 a.m. and 5:00 p.m. Monday through Friday unless authorized by the County to do otherwise. The Contractor shall consult with the County concerning scheduling of all work. The Contractor should have a supervisor/competent person in charge of his work at all times to whom the County may issue directives and who shall accept and act upon such directives. Failure for the supervisor to act on said directives shall be sufficient cause to give notice that the Contractor is in default of contract unless such directives would create potential personal injury or safety hazards.
10. Contractor shall make any special provisions necessary to protect the safety of their employees, civilians, road, and surrounding property in regards to close confines of power lines, roads, residences, traffic concerns, and disposal method of trees.
11. Contractor shall protect property such as fields, fences, telephone, light and power lines, buildings, ditches, bridges, culverts, private property, etc., against unnecessary injury, and shall repair any damage caused, restoring them immediately to the condition found prior to change. Contractor is to ensure protection and restoration of any gutter, curb, lawn and/or landscape area.
12. Traffic control is the responsibility of the Contractor and shall be accomplished in conformance with State, County, and Local highway construction codes. The contractor shall be solely responsible for pedestrian and vehicular safety and control within the work site and shall provide the necessary warning devices, barricades, and personnel needed to give safety, protection, and warning to persons and vehicular traffic within the area. Blocking of public streets shall not be permitted unless prior arrangements have been made in coordination with the appropriate State/County departments.
13. The Contractor is to contact the proper utility agencies any time assistance is needed to work safely around overhead or underground installations. The Contractor shall protect all utilities from damage, shall immediately contact the appropriate utility agency if damage should occur, and shall be responsible for all claims for damage due to their operations.
14. All trees, branches, debris, materials, etc. will be removed from the property. All debris will be removed from adjacent areas such as roads, ditches, sidewalks, lawns, streets, gutters, etc. Clean-up procedures are to be completed within two hours after debris have been placed around the site of each tree requiring removal. The work site is to be left equal to or cleaner than pre-work conditions. Tree parts dropped or lowered from trees are to be kept off of roads and private property. It shall be the responsibility of the Contractor to remove and dispose in a proper and acceptable manner all logs, brush, and debris resulting from the tree removal operations.
15. The County will inspect ongoing work at its discretion and will provide a final inspection of all work with the Contractor upon completion.
16. The Contractor and their employees will comply with all laws and regulations governing tree removal and will be responsible for any violation of local, state or federal regulations. The chosen

contractor will be required to follow the ANSI Z133 standards for tree work safety as well as South Carolina Best Management Practices (BMP's).

17. The County reserves the right to adjust or suspend tree removal operations when ground conditions, due to adverse weather, deem that damage to road systems and/or resources are excessive. In the event of a suspension the total contract term will not be shortened, but rather the suspension time will be added to the contract term.
18. Awards will be made based on bid price, conformity with the specifications, suitability to requirements, and other factors that are deemed by the County to affect the ability of the offeror to maintain a high service level.
19. Services furnished herein shall be classified as a lump sum bid for tree removal as listed on the attached designated maps.

**Add/Alternate #1**

An add/alternate #1 is asked by the department to obtain IDIQ pricing for future tree removal needs. Please attach pricing for the following: pine trees based on diameter and height, oak trees based on diameter and height, and sweet gum trees based on diameter and height. The County would also like to know of any additional costs to remove a tree near a power line. If so, please describe how close/distance in footage the tree would need to be in relation to the power line to incur this additional cost. Please use the separate Add/Alternate #1 form attached herein for your pricing. Note: Only the base bid pricing will be read the day of the public bid opening for this bid. Add/Alternate #1 pricing will not be read aloud but prices will be posted on the Georgetown County website following the bid opening.

1. **Submission of Questions**

Written sealed public bids for a Term Contract to provide **Tree Removal at Running Water Drive** shall be received in the Purchasing Office, Second Floor, Suite 239, 129 Screven Street, Georgetown, SC until the cut-off time shown in the bid timeline on page (3) of this document. Bids will then be publicly and promptly opened at the designated time by the Purchasing Officer. Bids that are not in the Purchasing Officer’s possession prior to the stated opening date and time will be considered **NON RESPONSIVE** and returned unopened. An official authorized to bind the offer must sign all proposals submitted.
3. **IMPORTANT OFFEROR NOTES:**

7. No Bidder may submit more than one bid. Multiple bids for different manufacturers but represented by the same firm will not be accepted. Bids offered directly from manufacturers shall indicate if a local dealer/representative will be involved.

8. Definitions:

- a) The terms “Proposer”, “Offeror”, “Vendor” or “Bidder” refer to those parties who are submitting sealed responses for the work set forth in this document to the OWNER, as distinct from a sub-bidder who provides a bid to the Bidder. The term “Contractor” refers to the successful Bidder.
- b) The term “**Tree Removal at Running Water Drive**” or “Service” refers to the **complete set of services** as specified in this document, in every aspect.
- c) The terms “Owner” and “County” refer to the County of Georgetown, South Carolina.
- d) Where the words “shall” or “must” are used, it signifies an absolute minimum function or capacity that, if not satisfied, may result in disqualification.
- e) Where the words “should”, “may”, or “is desirable” are used, it signifies desirable, but not mandatory functions or capacities. Bidders who are able to provide these functions or capacities may be evaluated more favorably than those who cannot.

9. Correction or Withdrawal of Bids; Cancellation of Awards

An offeror must submit in writing a request to either correct or withdraw a bid to the Procurement Officer. Each written request must document the fact that the offeror’s mistake is clearly an error that will cause him substantial loss.

- a) Correction of awards : An offeror shall not be permitted to correct a bid mistake after bid opening that would cause such offeror to have the low bid unless the mistake in the judgment of the Procurement Officer is clearly evident from examining the bid document; for example, extension of unit prices or errors in addition.
- b) Cancellation of awards prior to performance: When it is determined after an award has been issued but before performance has begun that Georgetown County’s requirements for the goods or services have changed or have not been met, the award or contract may be canceled and either reawarded or a new solicitation issued.

10. **Faxed or E-mailed bids will not be accepted by Georgetown County.**

11. If you need any reasonable accommodation for any type of disability in order to participate in this procurement, please contact the purchasing office as soon as possible.

12. Any deviations from the specifications or modification of this bid and any extra or incidental work or reductions in work shall be set forth in writing and signed by both parties prior to making such change. Any increase or decrease in the bid price resulting from such change shall be included in writing.
13. Exceptions: The bidder shall list on a separate sheet of paper any variations from, or exceptions to, the conditions and specifications of this bid. This sheet shall be labeled "Exception(s) to Bid Conditions and Specifications," and shall be attached to the bid. When Proposers find instances where they must take exception with certain requirements or specifications of the bid, all exceptions shall be clearly identified. Written explanations shall include the scope of the exceptions, the ramifications of the exceptions for the County of Georgetown, and a description of the advantage to be gained or disadvantages to be incurred by the County as a result of these exceptions. If none, write "NONE".
14. Georgetown County reserves the right to reject any or all bids, and to waive as an informality any irregularities contained in any bid as may be deemed in the best interest of the County. Georgetown County further reserves the right to reject any bid submitted, at its sole option, that the vendor may not be able to meet the service requirements of the bid.
15. Publicity releases: contractor agrees not to refer to award of any resulting contract in commercial advertising in such a manner as to state or imply that the products or services provided are endorsed or preferred by the user.
16. Material Safety Data Sheets: The County of Georgetown will not receive any materials, products, or chemicals which may be hazardous to an employee's health unless accompanied by a Material Data Sheet when received.
17. Ownership of Documents: Any reports, studies, photographs, negatives or other documents prepared by vendor in the performance of its obligations shall be the exclusive property of the procurer and all such material shall be remitted to the procurer by the vendor upon completion, termination or cancellation of this order. Vendor shall not use, willingly allow or cause to have such material used for any purpose other than performance of its obligations under this order without the prior written consent of the procurer.
18. Affirmative Action: The contractor will take affirmative action in complying with all Federal and State requirements concerning fair employment and employment of the handicapped, and concerning the treatment of all employees, without regard or discrimination by reason of age, race, color, religion, sex, national origin or physical handicap. The following are incorporated herein by reference: 41 C.F.R. 60-1.4, 60-250.4 and 60-741.4.
19. Bidders must clearly mark as "confidential" each part of their bid which they consider to be proprietary information that could be exempt from disclosure under section 30-4-40, Code of Laws of South Carolina 1976, as amended (Freedom of Information Act). If any part is designated as confidential, there must be attached to that part an explanation of how this information fits within one or more categories listed in section 30-4-40. The County reserves the right to determine whether this information should be exempt from disclosure and no legal action may be brought against the County or its agents for its determination in this regard.
20. CERTIFICATION REGARDING DRUG-FREE WORKPLACE:  
The contractor certifies that the vendor(s) will provide a "drug-free workplace" as that term is defined in Section 44-107-30 of the Code of Laws of South Carolina, 1976, as amended, by the complying with the requirements set forth in title 44, Chapter 107.

21. Certification of Non-Segregated Facilities

The federally-assisted construction contractor certifies that he does not maintain or provide, for his employees, any segregated facilities at any of his establishments and that he does not permit his employees to perform their services at any location, under his control, where segregated facilities are maintained. The federally-assisted construction contractor certifies that he will not maintain or provide, for his employees, segregated facilities at any of his establishments and that he will not permit his employees to perform their services at any location under his control where segregated facilities are maintained. The federally-assisted construction contractor agrees that a breach of this certification is a violation of the Equal Opportunity Clause in this Contract.

As used in this certification, the term "segregated facilities" means any waiting rooms, work areas, restrooms, and washrooms, restaurants and other eating areas, time clocks, locker rooms and other storage or dressing areas, parking lots, drinking fountains, recreation or entertainment areas, transportation, and housing facilities provided for employees which are segregated on the basis of race, color, religion, or national origin because of habit, local custom, or any other reason. The federally assisted construction contractor agrees that (except where he has obtained identical certifications from proposed subcontractors for specific time periods) he will obtain identical certifications from proposed subcontractors prior to the award of subcontracts exceeding \$10,000 which are not exempt from the provisions of the Equal Opportunity Clause and that he will retain such certifications in his files.

22. Nothing herein is intended to exclude any responsible vendor, his product or service or in any way restrain or restrict competition. On the contrary, all responsible vendors are encouraged to bid and their bids are solicited.

23. Acknowledgement of Addenda

Each contractor is responsible to verify the number of total addenda issued prior to bid. **Failure to acknowledge all addenda may disqualify the bidder.** All addenda are posted by the County at the website located at [www.gtcounty.org](http://www.gtcounty.org), select "Bid Opportunities" from the Quick Links box on the homepage. It is each proposer's responsibility to verify that all addenda have been received and acknowledged.

24. This Invitation for Bid covers the estimated requirements to provide **Tree Removal at Running Water Drive** for the Georgetown County Public Services Department/Stormwater Division. The purpose is to establish a Term Contract with firm pricing and delivery under which the department may place orders as needed. The right is reserved to extend the use of this contract to any County Department.

25. TERMS OF AGREEMENT / RENEWAL

The initial term of any resulting contract shall be for a period of one (1) calendar year, effective from date of contract award. The County reserves the right to negotiate with the successful bidder, after contract award, for an additional discount should available funds permit the purchase of additional units within the fiscal year. The County reserves the right, at its sole option, to renew the contract for four (4) additional consecutive terms, contingent upon satisfactory performance in the prior period, not to exceed a maximum term of five (5) years total.

26. PRICE ESCALATION/DE-ESCALATION:

Prices are to remain firm for the first contract period. In subsequent terms, the contractor may request, in writing at least sixty (60) days in advance of the contract ending date, an increase/decrease. Should the County elect to exercise the option to renew the contract for additional year(s), the contract prices for the additional years shall not exceed the percentage increase/decrease of the "Services" category of

the CPI-W SECTION OF THE COMSUMER PRICE INDEX of the United States Bureau of Labor Statistics for the latest twelve month for which statistics are available. Should the price change be granted and the County elects to renew the contract, the purchase order will reflect the changes.

27. Bids must be made on Proposal or Bid Form furnished or will be rejected. Proposals shall be typewritten or written in ink on the form prepared by the County. The person signing the bid shall initial all corrections or erasures.

28. Insurance

The successful bidder shall procure, maintain, and provide proof of, insurance coverage for injuries to persons and/or property damage as may arise from or in conjunction with, the work performed on behalf of the County by the bidder, his agents, representatives, employees or subcontractors. Proof of coverage as contained herein shall be submitted fifteen (15) days prior to the commencement of work and such coverage shall be maintained by the bidder for the duration of the contract period; for occurrence policies.

a. General Liability

Coverage shall be as broad as: Comprehensive General Liability endorsed to include Broad Form, Commercial General Liability form including Products/Completed Operations.

1. Minimum Limits

General Liability:

\$1,000,000 General Aggregate Limit

\$1,000,000 Products & Completed Operations

\$1,000,000 Personal and Advertising Injury

b. Automobile Liability

Coverage sufficient to cover all vehicles owned, used, or hired by the bidder, his agents, representatives, employees or subcontractors.

1. Minimum Limits

Automobile Liability:

\$1,000,000 Combined Single Limit

\$1,000,000 Each Occurrence Limit

\$5,000 Medical Expense Limit

c. Workers' Compensation

Limits as required by the Workers' Compensation Act of SC. Employers Liability, \$1,000,000.

d. Owners' & Contractors' Protective Liability

Policy will be in name of County. Minimum limits required are \$1,000,000.

e. Professional Liability

(not used)

f. Coverage Provisions

1. All deductibles or self-insured retention shall appear on the certificate(s).

2. The County of Georgetown, its officers/ officials, employees, agents and volunteers

shall be added as "additional insured" as their interests may appear. This provision does not apply to Professional Liability or Workers' Compensation/Employers' Liability.

3. The offeror's insurance shall be primary over any applicable insurance or self-insurance maintained by the County.
4. Shall provide 30 days written notice to the County before any cancellation, suspension, or void of coverage in whole or part, where such provision is reasonable.
5. All coverage for subcontractors of the bidder shall be subject to all of the requirements stated herein.
6. All deductibles or self-insured retention shall appear on the certificate(s) and shall be subject to approval by the County. At the option of the County, either; the insurer shall reduce or eliminate such deductible or self-insured retention; or the bidder shall be required to procure a bond guaranteeing payment of losses and related claims expenses.
7. Failure to comply with any reporting provisions of the policy(s) shall not affect coverage provided the County, its officers/officials, agents, employees and volunteers.
8. The insurer shall agree to waive all rights of subrogation against the County, its officers/officials, agents, employees or volunteers for any act, omission or condition of premises which the parties may be held liable by reason of negligence.
9. The bidder shall furnish the County certificates of insurance including endorsements affecting coverage. The certificates are to be signed by a person authorized by the insurance company(s) to bind coverage on its' behalf, if executed by a broker, notarized copy of authorization to bind, or certify coverage must be attached.
10. All insurance shall be placed with insurers maintaining an A.M. Best rating of no less than an A:VII. If A.M. Best rating is less than A:VII, approval must be received from County's Risk Officer.

#### 29. Workman's Compensation Coverage

Georgetown County, SC will require each contractor and service provider to maintain on file with the purchasing officer, a current Certificate of Insurance showing limits as required by the Workers' Compensation Act of SC: Employers Liability, \$1,000,000.

The law also recognizes "statutory employees." These are employees who work for a subcontractor who may be working for a business or another contractor. Employers should inquire whether or not a subcontractor working for them has workers' compensation insurance, regardless of the number of employees employed by the subcontractor. If the subcontractor does not, the subcontractor's injured employees would be covered under the employer's workers' compensation insurance. #### 30. Hold Harmless Clause



