**Question 1:** There are some conflicts in the bid specifications between the need for foam filled tires and brakes. If you are not going to use this machine for other purposes, and it is going to remain primarily a landfill machine towed by dozers or front end loaders, then I would suggest elimination of Electric Brakes as a requirement. On the other hand, if the brakes are important, then I suggest you eliminate the foam filled tires. Please let me know your thoughts on this.
