Question 1: Please explain the clause below. Are there any specific projects that we need to assign a cost estimate towards or do we just need to provide hourly rates by job title?

CONFIDENTIAL Cost of Services and man hours allocated

- 1) Each offeror shall include with their qualifications proposal, **in a clearly marked and separate, sealed envelope**, a non-binding estimate of the cost of services and the required costing data sheets indicating any estimate of the number of man-hours and other data. These will be kept sealed and confidential. Once the County selects a top ranked offeror, that company's estimate will be opened used as the basis for negotiation of a contract agreement. Upon successful negotiation of an agreement, all remaining cost and man hour estimates will be returned unopened.

Response: Since this is an RFQ for an Indefinite Delivery Contract, you are correct that there are no specific tasks upon which to base hours. Please provide a list personnel by discipline which one may expect to find in a typical roadway engineering project with associated "not to exceed" hourly rates. This list will be included as a part of any resulting contract document with the understanding that each project will be assigned on the basis of a negotiated task order.
