3. Our company visited the landfill and removed tonnage several months ago, has anything changed since then? We have had removed approximately 100 tons of tires in the most recent quarter.

4. Our company works 7 days week: regarding the landfill hours of Monday thru Friday 8:00 am to 3:30 pm would GTPO consider allowing us entrance into the landfill after hours on weekends. MTLs currently has this agreement in place with another landfill. References available. At the current time we are not able to allow weekend access for hauling. In the summer we do have limited weekend hours and could make arrangements with the hauler for access.
