

Inmate Commissary and Trust Fund Accounting Services

I. General Information:

- A. The Georgetown County Detention Center (GCDC) located in Georgetown, SC is seeking proposals from interested and qualified firms to provide comprehensive **Inmate Commissary and Trust Fund Accounting Services**. The purpose of this Request for Proposals is to establish a contract for providing a full-range of inmate commissary services, from ordering to delivering products to inmates. The term “commissary services” includes but is not limited to snack food, personal hygiene items, writing materials, over the counter (OTC) medications. Offeror shall be the sole supplier and coordinator of commissary services to inmates at the Georgetown County Detention Center. Services will be provided at no cost to the GCDC. Interested firms are invited to submit a proposal in accordance with the enclosed requirements.

- B. **Site inspection of the Georgetown County Detention Center is voluntary and will be available by prior appointment only. Individual Offerors should contact Ms. Myra McGirt at (843) 545-3422 at least two days prior to your desired visit date to schedule an appointment. However, any questions should be directed in writing to Ms. Nancy Silver at nsilver@gtcounty.org for answers via Addendum to all Offerors.**



- C. The term of any resulting contract shall be for one year from the date the contract is signed, with options for four consecutive twelve (12) month periods. The term of the contract cannot exceed a maximum of five (5) years total.
- D. Upon receipt by the County, each submittal will become the property of the County, without compensation to the offeror, for disposition or usage by the County at its discretion. The County shall have the sole discretion in evaluating both the proposal and the qualifications of the offerors. The County reserves the right to reject any and all submittals and is not bound to accept any submittal if it is contrary to the best interest of the County. The particulars of any proposal will remain confidential until a contract is signed with the successful offeror.

II. Specifications:

A. Current Operation

In Calendar Year 2018, the Georgetown County Detention Center (GCDC) housed an average daily population of 139 adults and no juvenile inmates.

An average of 80 individual orders are placed once per week. There was a six (6) month commissary sales total of \$57,957.30 (tax not included) from June 1, 2018 to November 30, 2018. All orders are currently keyed into the kiosk by the inmates during the week and submitted every Sunday evening. Deliveries are expected within 48 hours of ordering.

Additional information:

1. Inmate spending limit: \$80/week;
2. Number of kiosk: There are currently seven (7) ordering kiosks located in the cell blocks, one (1) deposit kiosk located in the GCDC lobby, and one (1) deposit kiosk located in Booking which accepts cash deposits only from funds taken from inmates upon admission.
3. The kiosk in the lobby for deposits charges a fee which the Detention Center receives no commission. Offeror will need to specify in their proposal if fees will be charged and include the amount. If expense for providing this service is different with cash vs. credit card, the proposal will need to specify. The Detention Center will not be responsible for any fees for deposits.
4. The vendor will not be responsible for removing cash from the kiosks in the lobby or Booking. Cash removal will be performed by Detention Center administrative personnel and deposited in the assigned commissary bank account.

B. RFP Specifications

The GCDC is seeking innovative proposals to meet our goals. Our goals are to provide a safe and secure canteen service to inmates and to increase the annual funds that we are currently generating from sales. Alternative solutions are encouraged as long as the intent of the specifications are met. For each

specification, respond according to your plan of action and/or capabilities. Your response should include the expected outcome of each action.

1. Commissary Services

- a. The contractor shall provide commissary services to the entire inmate population at least one (1) time per week. Deliveries of completed orders shall arrive no more than 48 hours after orders are sent.
- b. Currently, individual inmate commissary orders are delivered in clear, perforated plastic bags with tamper proof seals. There should be two (2) copies of the order receipt sealed within the bag. The receipt contains, at a minimum, the following information:
 - 1) Inmate name
 - 2) Inmate location
 - 3) Inmate ID number
 - 4) Items and quantity ordered
 - 5) Total of order with applicable itemized sales tax
 - 6) Two (2) signature lines

Security is of the utmost importance.

- c. A packing list should accompany each delivery. Orders should be packaged in clearly marked boxes/bags with the appropriate unit to which the orders are to be distributed.

2. Inmate Trust Fund Accounting Software

- a. Vendor shall provide computer software and computer related equipment needed for the accounting and commissary operations. The vendor will not be responsible for providing their own internet access; the existing County network will be made available for vendor's use. The current wiring/conduit for the vendor's kiosks and any other computer hardware is a $\frac{3}{4}$ conduit with a Cat5 cable.
- b. Vendor's software must be capable of integrating with the Detention Center's current jail management system (JMS), Offendertrak - product of Motorola Solutions. If the Detention Center changes the current JMS, the vendor must be willing to work with the new provider to find solutions for integration.
- c. The Detention Center's current inmate phone provider is Securus. It is not required by the vendor to have software capable of integration; however, proposals can include innovative ideas.
- d. Vendor shall provide a general ledger based inmate trust fund accounting program; such program shall be in accordance with generally accepted principles of accounting.

- e. The Inmate Trust Fund Accounting Software shall, at the minimum, perform the following functions:

General Ledger based with automatic transaction posting;

- 1) General Ledger reporting;
- 2) Date specific historical reporting;
- 3) Posting of debt charges to inmate accounts;
- 4) Maintain outstanding debt files with automatic collection upon deposits to inmates' accounts;
- 5) Reports of collected debt charges by category; reporting of outstanding debt records;
- 6) Checkbook reconciliation module;
- 7) Ability to rerun reconciliation reports at any time;
- 8) Release and check writing module;
- 9) Release and check card module;
- 10) Ability to merge duplicate inmate accounts;
- 11) Detailed ledger reporting for inmates' accounts;
- 12) Reports, on demand, of frozen, stale, active and inactive accounts;
- 13) Ability to restrict commissary purchasing for medical conditions or for disciplinary reasons;
- 14) Ability to restrict the maximum quantity on specific items;
- 15) Outstanding checks and deposits reporting;
- 16) Ability to reclaim stale checks;
- 17) Receipt generation for deposits and withdrawals;
- 18) Automatic backup of data on a daily basis;
- 19) Ability to create any ad hoc reports that the institution may require;
- 20) Product Category Limitations;

3. Expectations of the Contractor

The Contractor and its employees will be responsible for supervising the commissary services operation.

- a. The successful Contractor shall provide and support all hardware and software. The selected Contractor will be responsible for paying for any necessary upgrades. The Detention Center reserves the right to approve any services rendered. It is primarily the Contractor's responsibility to provide, install and maintain any hardware and/or software necessary to fulfill this contract. Please attach a list of all proposed hardware and/or software, including specifications, to your submittal.
- b. Currently, all orders are entered into the kiosk and are transmitted to the current ordering software system once per week. All schedules must be approved by the Detention Center

Director. Kiosk entry must be available in English and Spanish. Multiple languages are encouraged.

- c. Vendor must be responsible for providing an adequate number of any emergency order forms or other paper forms needed by the facility in instances where the kiosk is inoperable or inaccessible to inmates. The vendor will not be allowed to use the copy machine in the facility. Any paper forms required will be typed and listed by category. All paper forms must be approved. English and Spanish order forms must be available. Order forms in multiple languages are encouraged. Each item will be priced accurately and all prices must be approved by the Detention Center Director.

Please provide a sample emergency order or any other forms required with your submittal.

- e. Items on the list may include snack foods, soft drinks, fruit juices, candy, reading material, health and beauty aids, apparel, and OTC medications. We encourage a variety of sugar free foods, caffeine free soft drinks, reading glasses, “holiday packs” and other specialty items. Innovation and safety in this area are key.

Currently, the Detention Center is not offering phone cards to inmates through the current vendor. However, if this practice is enacted in the future, it will be expected of the vendor to have phone cards available for purchase by GCDC inmates.

The Detention Center Director, Deputy Director or the Operations Captain must approve all items. The facility reserves the right to reject any item on the form without cause. The Contractor will be responsible for surveying inmates to determine the best products to provide. The Contractor will also be responsible for promoting sales. Innovation in this area is key.

Please attach an itemized list of the proposed menu with prices in your submittal. Please include any products/ ideas that have worked well in comparable facilities.

- f. Items offered through the Commissary must meet the following specifications:
 - 1) Food items shall be wrapped/packaged and dated for individual consumption;
 - 2) All containers shall be made of non-breakable materials;
 - 3) All consumable products shall contain no alcohol – i.e., mouthwash, etc.

The offeror may be required to submit samples of any proposed product at no cost to the Detention Center.

- g. All prices shall remain firm for the duration of the contract period. It is the Detention Center’s objective to maintain a competitive retail pricing philosophy with regard to the retail price of the commissary items to inmates.

- h. The Contractor shall maintain sufficient inventory levels at the Contractor’s location in order to limit

shortages and/or backorders. The Contractor's qualifications to meet this requirement will be evaluated based on the ability of a Contractor to handle demands of commissary products ordered by the inmates. The Contractor should have an order fill rate of 98% or better. The inmate population of the jail is not static and changes very rapidly (increases and decreases in population). The GCDC requires this level of performance to reduce the number of credits and accounting problems for inmates that have been released during the order processing. The Contractor shall provide a method for handling damaged goods in their proposal.

- i. Georgetown County is not exempt from South Carolina Sales Tax. The Contractor will be responsible for charging the applicable South Carolina Sales Tax and for remitting to the South Carolina Department of Revenue. The South Carolina sales tax for Georgetown County is currently 7%, 6% SC state tax plus an additional 1% County tax.
- j. The Contractor must provide a method of handling "restocking or returned orders" for instances where an inmate may be released prior to receiving the order.
- k. Currently, inmates who have grievances concerning canteen services fill out a Grievance/Request Form and submit it to the Captain of Operations. Ultimately, the Contractor is responsible for answering the inmate grievance and resolving the matter within a reasonable time frame through communication with the Captain of Operations. The weekly invoice will not be paid until all grievances have been addressed and a corrective action can be taken. payment.
- l. All employees of the Contractor shall be required to adhere to all the Georgetown County Detention Center rules, regulations, policies and procedures.
- m. Any employee of the Contractor violating rules with respect to contraband, messages, bribes, contact or committing any inappropriate actions shall be immediately reprimanded, suspended or terminated by the Contractor. The proper action shall be coordinated with the Detention Center Administration and shall be dependent on the serious nature of the incident. The Contractor shall then surrender to the appropriate authorities for criminal action, if necessary. The Contractor and its staff shall be required to work closely with the Detention Center staff to ensure the safety of all employees, and safety conditions of the commissary services area(s). The Contractor will bear any loss resulting from dishonest acts on the part of its employees.
- n. Must provide a 24-Hour help line.
- o. Submit proposed holiday schedule.
- p. Provide a complete written standard operation procedures manual for the commissary services with your proposal.
- q. The Contractor will not remove or permit the removal of any of the fixtures or equipment owned by the Owner, nor will it remove any equipment furnished by the Contractor to replace lost, damaged or destroyed equipment belonging to the Detention Center.

- r. The Contractor shall be responsible for assuring that the correct merchandise is ordered and that deliveries are made to correspond with appropriate schedules and security measures. The Georgetown County Detention Center Administration may require notification prior to making any delivery.

4. Canteen Invoices

- a. All canteen services are at no cost to the Detention Center.
 - b. Invoices for payment from the sale of goods should be submitted to the Administrative Assistant to the Detention Center Director on a weekly basis. The weekly invoice, at a minimum, shall include:
 - 1) Invoice #
 - 2) Payment address
 - 3) Invoice date
 - 4) Total taxable sales
 - 5) Total non-taxable sales
 - 6) Sales tax to be paid
 - 7) Total due to Vendor
 - 8) An itemized list of total orders by inmate and items sold with quantities
- **Indigent Packs shall be shown separately.
- c. Invoices will be Net 14, given that no hold has been placed on payment
 - d. Invoices will be approved for payment by the Administrative Assistant to Detention Center Director after it is determined that all services pertaining to the invoice have been satisfactorily completed. This includes, but is not limited to resolving inmate grievances that pertain to canteen services. Also, the invoice must match the reported amount due according to the GCDC Jail Management System before payment will be made. Invoices will be reconciled weekly.

Include a sample invoice with the proposal.

5. Commission

- a. The GCDC is to be paid commission on sales and is looking for proven, innovative ways to improve our returns. GCDC expects to receive commission on all items except postage stamps and stamped envelopes. Any other exceptions must be listed.
- b. The Contractor shall submit a monthly report to the Georgetown County Detention Center itemizing total weekly sales divided into taxable and non-taxable purchases, total sales tax, net sales, stamp and stamped envelope purchases, indigent packs requested and the total commission earned. The commission rate should be included as well as the total monthly net amount due to the Detention Center. The report should account for the number of indigent packs provided weekly and attach a list of inmates to whom the indigent packs were delivered.

- c. Detention Center shall receive the commission check by the last day of each month, covering the previous month's sales. Monthly report should be mailed with the check. Check should be made payable to *Georgetown County Detention Center Inmate Welfare Fund*. Mail check to:

- d. Under the terms of this award, it is understood that the Contractor operates the total commissary services operation for its own account, retaining all profits, with the exception of the commission paid to the GCDC, and absorbing all losses. It is further understood that there is no guarantee of inmate population or total sales under this contract. The Detention Center does not in any way guarantee a profit to the Contractor.

6. Indigent Packs

- a. The Detention Center seeks innovative ways of keeping the indigent pack cost as low as possible. At a minimum, the successful Contractor will allow the Detention Center 10 indigent packs at no charge each week and/or to purchase any number above that at a rate not to exceed 15% above cost. This should include delivery and disbursement.
- b. The Detention Center reserves the right to purchase indigent packs from other sources as necessary.
- c. The Contractor shall provide computer software which is capable of determining which inmates are indigent in accordance with SC Minimum Standards for Jails. The software should recognize and distinguish inmates who have had a balance less than \$1.00 for seven (7) consecutive days. This software must also prevent indigent inmates from ordering more than one indigent kit in a 30 day period.
- d. The indigent packs will be delivered along with the commissary items each week. The indigent packs will be packaged individually by inmate name, inmate location, inmate ID number, a signature line for the inmate to sign, and a signature line for the officer delivering the indigent pack.
- e. Indigent packages will be purchased by the indigent inmate on the kiosk. The inmate's account will be charged for the kit and posted as a debt. The Contractor will be responsible for providing the Detention Center with a monthly invoice detailing the inmate's name and date the indigent pack was purchased. The Contractor will be paid for the indigent packs out of the commission.
- f. At a minimum, each pack should consist of the following items: eight (8) stamped legal size envelopes; thirty (30) pieces of 8 1/2 x 11 ruled paper; two (2) writing utensils (small pencil, i.e. golf pencil); one (1) short-handled toothbrush; one (1) tube of toothpaste (at least 2.75 ounces); and one (1) stick of deodorant (at least 1.6 ounces). In short, the Detention Center is seeking indigent packs to supply an inmate for at least 30 days. Any recommendation and/or samples of kits other than described above from the offeror are accepted in bid to include pricing.

- g. All items in the indigent packages must be approved by the Detention Center Director, Deputy Director, of Captain of Operations.

7. Additional Services

- a. The Contractor will be responsible for providing the following services and any additional services which will be a technological plus in day to day activities at the Detention Center to fulfill the needs of inmates. These services will be of no cost to the Detention Center.
 - 1) Contractor must provide computer hardware and software capable of scanning incoming inmate mail and making the mail available to inmates on the kiosk under their account.
 - 2) Contractor must provide software which gives the inmates the ability to file electronic grievances under their account.
 - 3) Contractor must have the ability to post the inmate rule book and any notices to inmates from Detention Center administration on the kiosk for their viewing.
 - 4) Contractor must make available electronic messaging for inmates so they have the ability to message family and friends for the purposes of reducing the amount of incoming and outgoing mail.
 - 5) Contractor must provide a visitors log software for each inmate under their account.
- b. It is the goal of the Detention Center to reduce the use of paper with the hopes of one day going paperless. It is requested of the vendor to provide any and all available services offered or ideas to assist the Detention Center in reaching this goal.

III. Proposal Submittal Requirements:

To allow for ease of review, all proposals should be submitted in the following format:

1. Executive Summary

All proposal responses will include an executive summary, outlining the basis of the proposal. Include a letter of transmittal with the official company name.

2. Company Information

This section should include an overview of the company, the primary business interest and/or operations including organization and affiliations. Include the company's address, contact numbers, when organized, where incorporated, how many years the company has been in operation, and credit available for this contract. Offeror shall have at least five (5) years previous experience in providing both inmate commissary and trust fund accounting systems to correction facilities comparable to Georgetown County's. If an Offeror is a successor company, the previous service company or companies must have had a combined total of five (5) years similar experience.

3. Experience and Qualifications

This section should include a review of the Offeror's experience in providing Inmate Trust Fund Accounting and Commissary Services. Include an organizational chart and biographic review and qualifications of all personnel to be involved in the provision and management of the services under this contract. The Offeror must have qualified project manager and staff, with identified support personnel dedicated to commissary services.

4. References

Offerors shall provide a minimum of five (5) references where Offeror provides similar services. Include length of contract, name & email of contact person, address, services provided and inmate population.

5. Overview of Computer Equipment to be provided.

6. Inmate Trust Fund Accounting Software

This section should provide a detailed review of the features of the software to be provided Offeror. Proposal should address the software requirements as outlined in section II.B.2 of this RFP. Include statement indicating the frequency of upgrades to the software, as well as, any cost incurred to the County.

7. Technical and Operational Support and Banking Services

Provide narrative outline of the technical and operational support the Detention Center will receive as part of this contract. Include list of contact personnel. The Offeror must have support/staff capable of responding to software/hardware issues within a matter of a few hours.

8. Operational Plan

Review in detail the method by which the inmates will place orders, how the orders will be processed, and delivery method. Discuss methods of quality, response to inmate grievances, how order errors are addressed, location of warehouse, assessment of customer satisfaction, methods to maximize and/or increase sales.

9. Commission Returns and Inmate Pricing

This section should clearly list the commission rate to be returned to the Georgetown County Detention Center, as well as the methods of calculating the monies returned. All offers should be in the form of a percentage of sales; no other options will be considered. Include sample commissary list with items priced out on list provided.

10. Transition Plan

This section should detail how you will handle the transition from the current provider, including but not limited to procedure on the transfer of data from their system to yours.

11. Mandatory Bid Submittal Forms

IRS Form W-9, Resident Certification for Local Preference, Mandatory Bid Submittal Form, and Exceptions Page

12. Any additional Information.

IV. Method of Award

A. General Procedures

Overall Basis for Award

Award will be made to the responsible organization offering the best value to the County. The County will select the organization for contract award on the basis of an integrated assessment of the strengths, weaknesses and risks associated with each proposal. The technical evaluation factors are equally as important as the evaluation of the financial return to the County. If a cost/technical tradeoff is warranted, the County will determine the best value by comparing the differences in the features and attributes of the technical proposals with the difference in the evaluated financial return to the County. The County further reserves the right not to make any award as a result of this solicitation.

Offerors' technical proposals shall be evaluated using the technical factors below.

B. Evaluation Factors

1. The proposal should fully address each of the evaluation criteria. The County shall assign a numerical score to the results of its evaluation.
2. The technical evaluation criteria and their respective weights are as follows:

- a. Experience **30 points**

Company information, experience, qualifications, past performance, and references will be evaluated.

- b. Software & Support: **30 points**

Evaluation of the computer equipment and software being proposed and technical and operational support that is being offered to the County.

- c. Methodology **20 points**

Review of the Offerors operational plan and transition plans for the required services and methods to maximize sales.

d. Commission Returns & Inmate Pricing

20 points

Clearly state the commission rate to be returned to the Detention Center as well as the methods of calculating the monies returned.

3. If necessary, the County reserves the right to negotiate with the highest ranked offeror. If negotiations are not deemed satisfactory with the highest ranked offeror, negotiations may be performed with the second highest ranked offeror, and so on and so forth until an acceptable negotiation can be made. Once a final determination has been made, a notice of intent to award letter will be mailed out to all respondents. The County of Georgetown is not required to furnish a statement of the reason(s) why a proposal was not deemed to be the most advantageous.

Instructions for Providers

These are general instructions and conditions that accompany each bid package. If more specific instructions are given in the individual bid package, those instructions should prevail.

1. **Submission of Questions**

Written sealed public bids for a Term Contract to provide **Inmate Commissary and Trust Fund Accounting Services** shall be received in the Purchasing Office, Second Floor, Suite 239, 129 Screven Street, Georgetown, SC until the cut-off time shown in the bid timeline on page three (3) of this document. Bids will then be publicly and promptly opened at the designated time by the Purchasing Officer. Bids that are not in the Purchasing Officer’s possession prior to the stated opening date and time will be considered **NON RESPONSIVE** and returned unopened. An official authorized to bind the offer must sign all proposals submitted.

3. **IMPORTANT OFFEROR NOTES:**

No bid will be accepted thereafter. The County assumes no responsibility for delivery of bids that are mailed. Georgetown County reserves the right to reject any or all bids and to waive any informalities and technicalities in the bid process.

6. **NON EXCLUSIVITY**

Nothing herein is intended nor shall be construed as creating any exclusive arrangement with Contractor. Any resulting contract shall not restrict the County from acquiring similar, equal or like goods and/or services from other entities or sources, when Staff determines internally that this resulting action is in the best interest of Georgetown County.

- a) The terms "Proposer", "Offeror", "Vendor" or "Bidder" refer to those parties who are submitting sealed responses for the work set forth in this document to the OWNER, as distinct from a sub-bidder who provides a bid to the Bidder. The term "Contractor" refers to the successful Bidder.
- b) The term "Inmate Commissary and Trust Fund Accounting Services" or "Service" refers to the **complete set of services** as specified in this document, in every aspect.

19. Ownership of Copyright: All right, title and interest in all copyrightable materials which vendor shall create in the performance of its obligations hereunder shall be the property of the procurer. Vendor agrees to assign and hereby does assign any and all interest it has in and to such material to procurer. Vendor agrees, upon the request of procurer to execute all papers and perform all other such acts necessary to assist procurer to obtain and register copyrights on such materials. Where applicable, works of authorship created by the vendor in the performance of its obligations hereunder, shall be considered "works for hire" as defined in the U.S. Copyright Act.
20. Ownership of Documents: Any reports, studies, photographs, negatives or other documents prepared by vendor in the performance of its obligations shall be the exclusive property of the procurer and all such material shall be remitted to the procurer by the vendor upon completion, termination or cancellation of this order. Vendor shall not use, willingly allow or cause to have such material used for any purpose other than performance of its obligations under this order without the prior written consent of the procurer.
21. Affirmative Action: The contractor will take affirmative action in complying with all Federal and State requirements concerning fair employment and employment of the handicapped, and concerning the treatment of all employees, without regard or discrimination by reason of age, race, color, religion, sex, national origin or physical handicap. The following are incorporated herein by reference: 41 C.F.R. 60-1.4, 60-250.4 and 60-741.4.
22. Inclusion and participation of disadvantaged, small, and local business entities is strongly encouraged, but minimum participation standards are not in effect for this project.
23. All Construction Contracts Over \$2,000:
 - a) Davis-Bacon Requirements. These contracts need to include a provision for compliance with the Davis-Bacon Act (40 USC 276a to a—7) and the Department of Labor implementing regulations (29 CFR Part 5). Under this Act, Contractors are required to include the contract provisions in Section 5.5 (a) of 29 CFR Part 5, and to pay wages to laborers and mechanics at a rate not less than the minimum wages specified in the wage determination made by the Secretary of Labor.  - b) Contract Work Hours and Safety Standard Act Requirements. The contracts must include a provision for compliance with Sections 103 and 107 of the Contract Work Hours and Safety Standards Act (40 USC 327-330) as supplemented by the Department of Labor regulations (29 CFR Part 5). Under Section 103 of the Act, each Contractor shall be required to compute the wages of every mechanic and laborer on the basis of a standard workweek of 40 hours. 24. Bidders must clearly mark as "confidential" each part of their bid which they consider to be proprietary information that could be exempt from disclosure under section 30-4-40, Code of Laws of South Carolina 1976, as amended (Freedom of Information Act). 25. CERTIFICATION REGARDING DRUG-FREE WORKPLACE:

The contractor certifies that the vendor(s) will provide a "drug-free workplace" as that term is defined in Section 44-107-30 of the Code of Laws of South Carolina, 1976, as amended, by the complying with the requirements set forth in title 44, Chapter 107.

26. Certification of Non-Segregated Facilities

The federally-assisted construction contractor certifies that he does not maintain or provide, for his employees, any segregated facilities at any of his establishments and that he does not permit his employees to perform their services at any location, under his control, where segregated facilities are maintained. The federally-assisted construction contractor certifies that he will not maintain or provide, for his employees, segregated facilities at any of his establishments and that he will not permit his employees to perform their services at any location under his control where segregated facilities are maintained. The federally-assisted construction contractor agrees that a breach of this certification is a violation of the Equal Opportunity Clause in this Contract.

As used in this certification, the term "segregated facilities" means any waiting rooms, work areas, restrooms, and washrooms, restaurants and other eating areas, time clocks, locker rooms and other storage or dressing areas, parking lots, drinking fountains, recreation or entertainment areas, transportation, and housing facilities provided for employees which are segregated on the basis of race, color, religion, or national origin because of habit, local custom, or any other reason. The federally assisted construction contractor agrees that (except where he has obtained identical certifications from proposed subcontractors for specific time periods) he will obtain identical certifications from proposed subcontractors prior to the award of subcontracts exceeding \$10,000 which are not exempt from the provisions of the Equal Opportunity Clause and that he will retain such certifications in his files.

27. Nothing herein is intended to exclude any responsible vendor, his product or service or in any way restrain or restrict competition. On the contrary, all responsible vendors are encouraged to bid and their bids are solicited.
28. Acknowledgement of Addenda
Each contractor is responsible to verify the number of total addenda issued prior to bid. **Failure to acknowledge all addenda may disqualify the bidder.** All addenda are posted by the County at the website located at www.georgetowncountysc.org, select "Purchasing" and "Current Bids". It is each proposer's responsibility to verify that all addenda have been received and acknowledged.
29. This Invitation for Bid covers the estimated requirements to provide Inmate Commissary and Trust Fund Accounting Services for the Georgetown County Sheriff's Office, Detention Center. The purpose is to establish a Term Contract with firm pricing and delivery under which the department may place orders as needed. The right is reserved to extend the use of this contract to any County Department.
30. TERMS OF AGREEMENT / RENEWAL
The initial term of any resulting contract shall be for a period of one (1) calendar year, effective from date of contract award. The County reserves the right to negotiate with the successful bidder, after contract award, for an additional discount should available funds permit the purchase of additional units within the fiscal year. The County reserves the right, at its sole option, to renew the contract for four (4) additional consecutive terms, contingent upon satisfactory performance in the prior period, not to exceed a maximum term of five (5) years total.
31. PRICE ESCALATION/DE-ESCALATION:
Prices are to remain firm for the first contract period. In subsequent terms, the contractor may request, in writing at least sixty (60) days in advance of the contract ending date, an increase/decrease. Should the County elect to exercise the option to renew the contract for additional year(s), the contract prices for the additional years shall not exceed the percentage increase/decrease of the "Services" category of the CPI-W SECTION OF THE COMSUMER PRICE INDEX of the United States Bureau of Labor Statistics for the latest twelve month for which statistics are available. Should the price change be granted and the County elects to renew the contract, the purchase order will reflect the changes.
32. Bids must be made on Proposal or Bid Form furnished or will be rejected. Proposals shall be typewritten or written in ink on the form prepared by the County. The person signing the bid shall initial all corrections or erasures.
33. Insurance
The successful bidder shall procure, maintain, and provide proof of, insurance coverage for injuries to persons and/or property damage as may arise from or in conjunction with, the work performed on behalf of the County by the bidder, his agents, representatives, employees or subcontractors. Proof of coverage as contained herein shall be submitted fifteen (15) days prior to the commencement of work and such coverage shall be maintained by the bidder for the duration of the contract period; for occurrence policies.
- a. General Liability

Coverage shall be as broad as: Comprehensive General Liability endorsed to include Broad Form, Commercial General Liability form including Products/Completed Operations.

1. Minimum Limits

General Liability:

- \$1,000,000 General Aggregate Limit
- \$1,000,000 Products & Completed Operations
- \$1,000,000 Personal and Advertising Injury
- \$1,000,000 Each Occurrence Limit

b. Automobile Liability

Coverage sufficient to cover all vehicles owned, used, or hired by the bidder, his agents, representatives, employees or subcontractors.

1. Minimum Limits

Automobile Liability:

- \$1,000,000 Combined Single Limit
- \$1,000,000 Each Occurrence Limit
- \$5,000 Medical Expense Limit

c. Workers' Compensation

Limits as required by the Workers' Compensation Act of SC. Employers Liability, \$1,000,000.

d. Owners' & Contractors' Protective Liability

Policy will be in name of County. Minimum limits required are \$1,000,000.

e. Professional Liability (a/k/a Errors and Omissions)

Minimum limits are \$1,000,000 per occurrence.

f. Coverage Provisions

1. All deductibles or self-insured retention shall appear on the certificate(s).
2. The County of Georgetown, its officers/ officials, employees, agents and volunteers shall be added as "additional insured" as their interests may appear. This provision does not apply to Professional Liability or Workers' Compensation/Employers' Liability.
3. The offeror's insurance shall be primary over any applicable insurance or self-insurance maintained by the County.
4. Shall provide 30 days written notice to the County before any cancellation, suspension, or void of coverage in whole or part, where such provision is reasonable.
5. All coverage for subcontractors of the bidder shall be subject to all of the requirements stated herein.
6. All deductibles or self-insured retention shall appear on the certificate(s) and shall be subject to approval by the County. At the option of the County, either; the

insurer shall reduce or eliminate such deductible or self-insured retention; or the bidder shall be required to procure a bond guaranteeing payment of losses and related claims expenses.

7. Failure to comply with any reporting provisions of the policy(s) shall not affect coverage provided the County, its officers/officials, agents, employees and volunteers.
8. The insurer shall agree to waive all rights of subrogation against the County, its' officers/officials, agents, employees or volunteers for any act, omission or condition of premises which the parties may be held liable by reason of negligence.
9. The bidder shall furnish the County certificates of insurance including endorsements affecting coverage. The certificates are to be signed by a person authorized by the insurance company(s) to bind coverage on its' behalf, if executed by a broker, notarized copy of authorization to bind, or certify coverage must be attached.
10. All insurance shall be placed with insurers maintaining an A.M. Best rating of no less than an A:VII. If A.M. Best rating is less than A:VII, approval must be received from County's Risk Officer.

34. Workman's Compensation Coverage

Georgetown County, SC will require each contractor and service provider to maintain on file with the purchasing officer, a current Certificate of Insurance showing limits as required by the Workers' Compensation Act of SC: Employers Liability, \$1,000,000.

The law also recognizes "statutory employees." These are employees who work for a subcontractor who may be working for a business or another contractor. Employers should inquire whether or not a subcontractor working for them has workers' compensation insurance, regardless of the number of employees employed by the subcontractor. If the subcontractor does not, the subcontractor's injured employees would be covered under the employer's workers' compensation insurance. If the subcontractor does not carry workers' compensation insurance, then the owner or the principal contractor would be liable just as if the subcontractor's employee was one of their employees.

35. Hold Harmless Clause

The Contractor shall, during the term of the contract including any warranty period, indemnify, defend, and hold harmless the County, its officials, employees, agents, and representatives thereof from all suits, actions, or claims of any kind, including attorney's fees, brought on account of any personal injuries, damages, or violations of rights, sustained by any person or property in consequence of any neglect in safeguarding contract work or on account of any act or omission by the contractor or his employees, or from any claims or amounts arising from violation of any law, bylaw, ordinance, regulation or decree. The vendor agrees that this clause shall include claims involving infringement of patent or copyright.

36. Condition of Items

All items shall be new, in first class condition, including containers suitable for shipment and storage, unless otherwise indicated herein. Verbal agreements to the contrary will not be recognized.

37. Workmanship and Inspection

All work under this contract shall be performed in a skillful and workmanlike manner. The County may, in writing, require the Contractor to remove any employee from work that the County deems incompetent or careless.

Further, the County may, from time to time, make inspections of the work performed under this contract. Any inspection by the County does not relieve the Contractor from any responsibility regarding defects or other failures to meet the contract requirements.

38. Invoicing and Payment

The firm shall submit invoices on a frequency to be determined, as agreed upon by the County, for each payment requested. Such invoice shall also include a detailed breakdown of all charges. All such invoices will be paid within thirty (30) days unless any items thereon are questioned, in which event payment will be withheld pending verification of the amount claimed and the validity of the claim. The firm shall provide complete cooperation during any such investigation. All invoices shall be forwarded to the following address:

Individual contractors shall provide their social security numbers, and proprietorships, partnerships, and corporations shall provide their federal employer identification number on the pricing form.

39. South Carolina Sales Tax

The County of Georgetown, SC is not exempt and pays the appropriate SC sales tax on all applicable purchases. Effective May 01, 2015, the sales tax rate increased from 6% to 7% which includes a VAT for Georgetown County.

40. Assignment of Contract

This contract may not be assigned in whole or part without the written consent of the Purchasing Officer.

41. Termination

Subject to the provisions below, the contract may be terminated by the County upon sixty (60) days advance written notice to the other party; but if any work or service hereunder is in progress, but not completed as of the date of termination, then this contract may be extended upon written approval of the County until said work or services are completed and accepted.

a. Termination for Convenience

In the event that this contract is terminated or canceled upon request and for the convenience of the County, without the required sixty (60) days advance written notice, then the County shall negotiate reasonable termination costs, if applicable.

b. Termination for Cause

Termination by the County for cause, default or negligence on the part of the contractor shall be excluded from the foregoing provision; termination costs, if any, shall not apply.

The sixty (60) days advance notice requirement is waived in the event of Termination for Cause.

c. Non-Appropriation:

It is understood and agreed by the parties that in the event funds are not appropriated in the current fiscal year or any subsequent fiscal years, this contract will become null and void and the County will only be required to pay for services completed to the satisfaction of the County.

42. Default

In case of default by the contractor, for any reason whatsoever, the County may procure the goods or services from another source and hold the contractor responsible for any resulting excess cost and may seek other remedies under law

43. Severability

In the event that any provision shall be adjudged or decreed to be invalid, such ruling shall not invalidate the entire Agreement but shall pertain only to the provision in question and the remaining provisions shall continue to be valid, binding and in full force and effect.

44. Applicable Laws

This Agreement shall be governed by and construed in accordance with the laws of the State of South Carolina, U.S.A.

45. Claims and Disputes:

All claims, disputes and other matters in question between parties arising out of, or relating to, this Agreement, or the breach thereof, shall be decided in the Circuit Court of the Fifteenth Judicial circuit in Georgetown County, South Carolina. By executing this Agreement, all parties specifically consent to venue and jurisdiction in Georgetown County, South Carolina and waive any right to contest jurisdiction and venue in said Court.

46. Rights of County

The County reserves the right to reject all or any part of any bid, waive informalities and award the contract to the lowest responsive and responsible bidder to best serve the interest of the County.

47. Award of Bid

In determining the lowest responsive and responsible bidder, in addition to price, there shall be considered the following:

- (a) The ability, capacity and skill of the bidder to perform the contract.
- (b) Whether the bidder can perform the contract within the time specified, without delay of interference.
- (c) The character, integrity, reputation, judgment, experience and efficiency of the bidder.
- (d) The quality of performance on previous contracts.
- (e) The previous and existing compliance by the bidder with laws and ordinances relating to the contract.
- (f) The sufficiency of the financial resources to perform the contract to provide the service.
- (g) The quality, availability and adaptability of the supplies or contractual services to the particular use required.
- (h) The ability of the bidder to provide future maintenance and service.
- (i) The discount terms and conditions of the bid.
- (j) Delivery time.

48. Notice of Award

A *Notice of Intent to Award* will be mailed to all respondents.

49. Protest

Bidders may refer to Sections 2-67, 2-73, and 2-74 of Ordinance #2008-09, also known as the Georgetown County, South Carolina Purchasing Policy to determine their remedies concerning this competitive process. The failure to be awarded a bid shall not be valid grounds for protest.

50. Debarment

By submitting a bid, the offeror certifies to the best of its knowledge and belief, that it and its principals, sub-contractors and assigns are not presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from covered transactions by any Federal, State or local department or agency. A copy of the County's debarment procedure in accordance with Section 2-68 of Ordinance #2008-09, also known as the Georgetown County, South Carolina Purchasing Policy is available upon request.

51. Firm Pricing for County Acceptance

Bid price must be firm for County acceptance for 90 days from bid opening date. "Discount from list," bids are not acceptable unless specifically requested.

52. Unit Prices and Extension

Bid unit price on quantity specified -- extend and show total. In case of errors in extension, unit prices shall govern. Bids subject to unlimited price increases will not be considered.

53. Use of Brand Names (If Appropriate)

Unless otherwise stated in an Invitation for Bid, the name of a certain brand, make or manufacturer does not restrict bidders to the specific brand, make or manufacturer named; it conveys the general style, type, character, and quality of the article desired, and any article which the County in its sole discretion determines to be the equal of that specified, considering quality, workmanship, economy of operation, and suitability for the purpose intended, shall be accepted. Any catalog, brand name or manufacturer's reference used in bid invitation is descriptive - NOT restrictive - it is to indicate type and quality desired. Bids on brands of like nature and quality will be considered. If bidding on other than reference or specifications, bid must show manufacturer, brand or trade name, catalog number, etc. of article offered. If other than brand(s) specified is offered, illustrations and complete description must be submitted with bid. Samples may be required. If bidder makes no other bid and takes no exception to specifications or reference data, he will be required to furnish brand names, numbers, etc., as specified. 54. Delivery After Receipt of Order (ARO)

Bid must show the number of days required to place material in using agency's receiving room under normal conditions. 59. Any attempt by the vendor to influence the opinion of County Staff or County Council by discussion, promotion, advertising, misrepresentation of the submittal or purchasing process or any procedure to promote their offer will constitute a violation of the vendor submittal conditions and will cause the vendor's submittal to be declared null and void.

60. Apparent omission of a detailed description concerning any point, shall be regarded as meaning the best commercial practice is to prevail and that only material and workmanship of the finest quality are to be used.

61. Response Clarification

Georgetown County reserves the right to request additional written or oral information from Bidders in order to obtain clarification of their Responses.

62. Georgetown County, SC has a Local Vendor Preference Option by ordinance:

Sec 2-50. Local Preference Option

1. A vendor shall be deemed a Local Georgetown County vendor for the purposes of this Section if such vendor is an individual, partnership, association or corporation that is authorized to transact business within the State, maintains an office in Georgetown County, and maintains a representative inventory or commodities within the County on which the bid is submitted, and has paid all taxes duly assessed.

2. This option allows the lowest local Bidder whose bid is within five-percent (5%) of the lowest non-local Bidder to match the bid submitted by the non-local Bidder and thereby be awarded the contract. This preference shall apply only when (a) the total dollar purchase is \$10,000 or more; (b) the vendor has a physical business address located and operating within the limits of Georgetown County and has been doing business in the County for a period of twelve (12) months or more; and (c) the vendor provides proof of payment of all applicable Georgetown County taxes and fees if so requested.
3. Should the lowest responsible and responsive Georgetown County bidder not exercise its right to match the bid as granted herein, the next lowest qualified Georgetown County bidder shall have that right and so on. The right to exercise the right to match the bid shall be exercised within 24 hours of notification of the right to match the non-Georgetown County bidder's bid.
4. In order to qualify for the local preference authorized by this Section, the vendor seeking same shall be required to submit with its bid a statement containing relevant information which demonstrates compliance with the provisions of this Section. This statement shall be on a form provided by the County purchasing department and shall be signed under penalty of perjury. Failure to provide such affidavit at the time the bidder submits its bid shall constitute a waiver of any claim for preference.
5. For all contracts for architecture, professional engineering, or other professional services governed by § 2-56, Architect-Engineer and Land Surveying Services – Public Announcement and Selection Process, the county shall include the local business status of a firm among the factors considered when selecting which firms are “most highly qualified.” In determining which firm is the “most qualified” for purposes of negotiating a satisfactory contract, preference shall be given to a local business where all other relevant factors are equal.
6. Local preference shall not apply to the following categories of contracts: (a) Goods or services provided under a cooperative purchasing agreement or similar “piggyback” contract; (b) Contracts for professional services except as provided for in section five (§5) above; (c) Purchases or contracts which are funded, in whole or in part, by a governmental or other funding entity, where the terms and conditions of receipt of the funds prohibit the preference; (d) Purchases or contracts made pursuant to a noncompetitive award process, unless otherwise provided by this section; or (e) Any bid announcement which specifically provides that the general local preference policies set forth in this section are suspended due to the unique nature of the goods or services sought, the existence of an emergency as found by either the county council or county administrator, or where such suspension is, in the opinion of the county attorney, required by law.

Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following.

- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)

Further, in certain cases where a Form W-9 has not been received, the rules under section 1446 require a partnership to presume that a partner is a foreign person, and pay the section 1446 withholding tax. Therefore, if you are a U.S. person that is a partner in a partnership conducting a trade or business in the United States, provide Form W-9 to the partnership to establish your U.S. status and avoid section 1446 withholding on your share of partnership income.

In the cases below, the following person must give Form W-9 to the partnership for purposes of establishing its U.S. status and avoiding withholding on its allocable share of net income from the partnership conducting a trade or business in the United States.

Example. Article 20 of the U.S.-China income tax treaty allows an exemption from tax for scholarship income received by a Chinese student temporarily present in the United States. Under U.S. law, this student will become a resident alien for tax purposes if his or her stay in the United States exceeds 5 calendar years. However, paragraph 2 of the first Protocol to the U.S.-China treaty (dated April 30, 1984) allows the provisions of Article 20 to continue to apply even after the Chinese student becomes a resident alien of the United States. A Chinese student who qualifies for this exception (under paragraph 2 of the first protocol) and is relying on this exception to claim an exemption from tax on his or her scholarship or fellowship income would attach to Form W-9 a statement that includes the information described above to support that exemption.

If you are a nonresident alien or a foreign entity, give the requester the appropriate completed Form W-8 or Form 8233.

Backup Withholding

What is backup withholding? Persons making certain payments to you must under certain conditions withhold and pay to the IRS 24% of such payments. This is called "backup withholding." Payments that may be subject to backup withholding include interest, tax-exempt interest, dividends, broker and barter exchange transactions, rents, royalties, nonemployee pay, payments made in settlement of payment card and third party network transactions, and certain payments from fishing boat operators. Real estate transactions are not subject to backup withholding.

You will not be subject to backup withholding on payments you receive if you give the requester your correct TIN, make the proper certifications, and report all your taxable interest and dividends on your tax return.

Payments you receive will be subject to backup withholding if:

1. You do not furnish your TIN to the requester,

Updating Your Information

Enter your TIN in the appropriate box. If you are a resident alien and you do not have and are not eligible to get an SSN, your TIN is your IRS individual taxpayer identification number (ITIN). Enter it in the social security number box. If you do not have an ITIN, see *How to get a TIN* below.

If you are a sole proprietor and you have an EIN, you may enter either your SSN or EIN.

If you are asked to complete Form W-9 but do not have a TIN, apply for a TIN and write "Applied For" in the space for the TIN, sign and date the form, and give it to the requester. For interest and dividend payments, and certain payments made with respect to readily tradable instruments, generally you will have 60 days to get a TIN and give it to the requester before you are subject to backup withholding on payments. The 60-day rule does not apply to other types of payments. You will be subject to backup withholding on all such payments until you provide your TIN to the requester.

Note: Entering "Applied For" means that you have already applied for a TIN or that you intend to apply for one soon.

Caution: A disregarded U.S. entity that has a foreign owner must use the appropriate Form W-8.

Privacy Act Notice

MANDATORY VENDOR SUBMITTAL FORM

WHEREAS, Georgetown County Council desires to further its support of local businesses when awarding contracts for the provision of supplies and construction services to the County through its established procurement procedures.

THEREFOR pursuant to Georgetown County, SC Ordinance #2014-02 as adopted, §2-50 Local Preference Option, the Georgetown County Purchasing Officer requests each offeror provide Residence Certification. The Local Preference Option provides some restrictions on the awarding of governmental contracts; provisions of which are stated below:

Sec 2-50. Local Preference Option

1. A vendor shall be deemed a Local Georgetown County vendor for the purposes of this Section if such vendor is an individual, partnership, association or corporation that is authorized to transact business within the State, maintains an office in Georgetown County, and maintains a representative inventory or commodities within the County on which the bid is submitted, and has paid all taxes duly assessed.
2. This option allows the lowest local Bidder whose bid is within five-percent (5%) of the lowest non-local Bidder to match the bid submitted by the non-local Bidder and thereby be awarded the contract. This preference shall apply only when (a) the total dollar purchase is \$10,000 or more; (b) the vendor has a physical business address located and operating within the limits of Georgetown County and has been doing business in the County for a period of twelve (12) months or more; and (c) the vendor provides proof of payment of all applicable Georgetown County taxes and fees if so requested.
3. Should the lowest responsible and responsive Georgetown County bidder not exercise its right to match the bid as granted herein, the next lowest qualified Georgetown County bidder shall have that right and so on. The right to exercise the right to match the bid shall be exercised within 24 hours of notification of the right to match the non-Georgetown County bidder's bid.
4. In order to qualify for the local preference authorized by this Section, the vendor seeking same shall be required to submit with its bid a statement containing relevant information which demonstrates compliance with the provisions of this Section. This statement shall be on a form provided by the County purchasing department and shall be signed under penalty of perjury. Failure to provide such affidavit at the time the bidder submits its bid shall constitute a waiver of any claim for preference.

5. For all contracts for architecture, professional engineering, or other professional services governed by § 2-56, Architect-Engineer and Land Surveying Services – Public Announcement and Selection Process, the county shall include the local business status of a firm among the factors considered when selecting which firms are “most highly qualified.” In determining which firm is the “most qualified” for purposes of negotiating a satisfactory contract, preference shall be given to a local business where all other relevant factors are equal.
6. Local preference shall not apply to the following categories of contracts:
 - (a) Goods or services provided under a cooperative purchasing agreement or similar “piggyback” contract;
 - (b) Contracts for professional services except as provided for in section five (§5) above;
 - (c) Purchases or contracts which are funded, in whole or in part, by a governmental or other funding entity, where the terms and conditions of receipt of the funds prohibit the preference;
 - (d) Purchases or contracts made pursuant to a noncompetitive award process, unless otherwise provided by this section; or
 - (e) Any bid announcement which specifically provides that the general local preference policies set forth in this section are suspended due to the unique nature of the goods or services sought, the existence of an emergency as found by either the county council or county administrator, or where such suspension is, in the opinion of the county attorney, required by law.
