3. How does the supplier get into restricted areas? **The Supplier will need to be escorted by Facility Service to gain entry into the restricted areas.**
4. Can we get access to the current State Reports? **There reports can be viewed through the Facility Services Manager.**
5. What is the County currently paying for maintenance at this time? **\$10,638 per year**
