5. One (1) engineer plan, if sign exceeds 32 square feet, indicating the sign meets or exceeds wind load of 130 mph in any directions.

7. Two (2) landscape plans indicating the location, number, and type of plant species being installed.
8. Color samples along with the corresponding names of all proposed colors along with two (2) copies of a scaled color rendering indicating location of each color.
