Question: Lease group 026 Financing -\$ 1,659,521.00 8 years arrears; would we be disqualified if we submitted a bid of 5 years instead of 8 years with a balloon payment at end of the loan period with an option to finance the balloon payment for 3 years?

Response: In speaking with the Director of Finance this morning, the department would not consider this grounds for disqualification, however the County does not have an interest in that type of arrangement. If your institution cannot provide financing for the full 8 year term, the County would be more inclined to consider an offer that alternately provides a rate for the maximum term you are able to offer, as stated below:

I would rather the bidders state their limitations and substitute their maximum period for amortization if our suggested term of financing is longer than they are willing to provide a fixed rate for.
