This clarification is being provided to all registered respondents in follow-up to the Mandatory Pre-Bid Conference and Site Inspection, and in answer to the questions received below. QUESTION: Is there any written reference that the structured cable has been pulled from this bid, and will be done by Premier? Can this section be left out?

ANSWER: The GC needs to bid what is on the construction documents. In Section 01200 Price and Payment Procedures: Under Allowances there is a section labeled Telecommunications/Data that is to be performed by Premiere Communications. They have provided a quote and coordinated this with the County MIS Department Leslie and the architect under the existing County contract agreement.

QUESTION: We cannot locate the “Contractors Qualification Statement for Construction Tabulation Form” in the project manual that is listed item #13, of Addendum 3 (page 3 of 33).

ANSWER: That is a typographical error. The corrected item should read:
