This addendum will amend **Bid #09-012, Rural Roads Improvement Program, FY09** originally issued on Friday, January 30, 2009. This clarification is being provided to all known and registered respondents. QUESTION: I do not see a clause on LD (liquidated damages) in the bid documents. Please verify if there are to be liquidated damages associated with the job.

ANSWER: The required target date for completion is in the last sentence of the first paragraph on page two (2), thus:

➤ **Improvements must be completed within eight (8) months after contract award.**

The County did not specify within the bid documents a per diem fee to be levied for liquidated damages. In the past this has not been a problem. If a situation does arise, the County will negotiate with the contractor to utilize contract funds retainage to offset any liquidated damages that may arise due to non-compliance.
