QUESTION: Are there any plans associated with this job?

ANSWER: No, the specifications and requirements are listed for each road, and it will be the responsibility of the contractor to construct to the standards as provided.

QUESTION: In section 5 (5.03-a) the sub-grade proof rolling spec minimum weight is 40 tons. The maximum legal weight for a loaded tri-axle truck is 34 tons. Since this 34 ton weight has been the industry standard in the past, will it also suffice for this project?

ANSWER: That will suffice.

QUESTION: Is there going to be binder under the Surface course. It is not listed in the location specification but it is listed in the Inspection and Testing?

ANSWER: There is not a binder course.
