This addendum will amend **Bid #09-020, Construction of YMCA Highway SC51 Turn Lanes, FY09** originally issued on Friday, March 20, 2009. This clarification is being provided to all known and registered correspondents. All addenda and original bid documents are also available online at: www.georgetowncountysc.org, select “purchasing” and then “current bids”.

The following items were discussed, in no specific order, with the contractors in attendance, representatives from SC-DOT and Georgetown County Public Works:

- 1) The General Contractor for the site is FBi Construction, and the site work contractor is the Ben Cox Company;
- 2) Construction traffic will need the ability to access the site during the turn lane project;
- 3) It would be preferable complete the base courses into the site, and to coordinate with the site work contractor to place the final asphalt coat simultaneously with the paving of the parking areas at the YMCA facility;
- 4) SC-DOT representatives will inspect the work as required, and all work must meet SC-DOT requirements and specifications;
- 5) The waterline placement should be completed PRIOR to the commencement of work on the turn lane project;
- 6) The pavement placement on the north highway side private drive entrance will only extend to the right-of-way limit;
- 7) The drawings appeared clear in all respects and no additional questions were asked;
- 8) The contractors registered in attendance, as attached, will comprise the “Qualified Bidders List” and only those contractors may submit an offer.
