This addendum will amend **Bid #09-022, Materials to Construct Wooden Litchfield Beach Handicap Walkovers** originally issued on Friday, February 27, 2009. This clarification is being provided to all known and registered correspondents in response to inquiries received for additional information. All addenda and original bid documents are also available online at: <http://www.georgetowncountysc.org>, select “purchasing” and then “current bids”.

**QUESTION:** We would be interested in constructing the beach walkovers. Can we get specifications?

**ANSWER:** The solicitation is for “Materials Only” with installation by the County’s Facility Services Division. This will permit the County to perform within budget limitations.



**QUESTION:** Can you clarify what a Dog Eared Picket is. I know what dog eared is but that is on fencing. X4’s, 1x6’s, or 1x8’s.

**ANSWER:** This item description should be corrected to a “Beveled 2-End Baluster” of nominal 1x1 treated lumber, 48-inches (48”) in length.

**QUESTION:** I need to know on the 2x8 joist hangers, are the face or top loading.

**ANSWER:** The joist hangers supplied should be face loading.

**QUESTION:** Based on the solicitation, this is a single vendor purchase in which there will be one drop shipment of the materials requested. In paragraph 14 and 15 it indicates that this is a term contract for one year with additional options. Does this mean that there can be additional purchases under this contract at the same quoted prices along with renewal options?

**ANSWER:** **We anticipate a single purchase at this time, however should additional funds become available and allow the construction of additional beach walk-overs, the County would prefer to reserve the right to utilize the same bid rather than going through a re-solicitation to procure the same product. In these cases we will confirm if the price can still be honored.**

**QUESTION:** Paragraph 19 discusses the requirements of insurance for the work performed. This includes, but is not limited to General, Automobile, Workman's Compensation, Owner's and Contractor's Liability in the name of the County. In the policy "the County of Georgetown, its' officer/officials, employees, agents and volunteers shall be added as "additional insures". Again, this being a vendor purchase where materials will be purchased, does the insurance requirements apply here or is this a boilerplate contract that is also used for services?

**ANSWER:** **No knowing if the successful offeror will ship by commercial freight or utilizing their own truck and driver, we cannot foresee whether or not a company driver could sustain an injury while making a delivery on County property. To avoid a liability claim against the County in such an event it is unfortunately necessary that an insurance certificate must be on file. For this solicitation "Owners and Contractor's Liability" is not required.**
