This addendum provides responses to the following questions:

Question 1: Will fuel blending be considered as "recycling" for the oil based paint. Fuel blending involves mixing of high BTU value flammable materials into a fuel to be shipped to cement kilns to burn as fuel.

Response: yes

Question 2: In regards to the latex paint, will "waste to energy" be deemed by the county as "recycling". Waste to energy involves burning the material in a high energy incinerator which then uses the heat generated to produce electricity.

Response: yes

Question 3: Will any of the waste be already packaged by the county (such as cubic yard boxes of the latex or oil based paints). If this is the case is the vendor still required to provide cubic yard boxes?

Response: None of the waste will be packaged by the County.
